A 2-year-old male patient received BNT162b2 (BNT162B2), on 18Nov2021 as dose 1, single (Batch/Lot number: unknown), in right arm for covid-19 immunisation. The patient's relevant medical history was not reported. There were no concomitant medications. The following information was reported: EYE HAEMORRHAGE (death, medically significant), EAR HAEMORRHAGE (death), MOUTH HAEMORRHAGE (death), EPISTAXIS (death) all with onset 18Nov2021, outcome "fatal" and all described as "Patient began bleeding out the mouth, eyes, nose and ears within six hours of shot. Died that night". The patient date of death was 18Nov2021. Reported cause of death: "Patient began bleeding out the mouth, eyes, nose and ears within six hours of shot. Died that night". It was not reported if an autopsy was performed. Clinical course: It was reported that If there was any way to locate, reach out to, and speak to the family of this 2 year old, Let us not forget this 2 year old boy, who was a victim of the covid-19 inoculation program and whose life having been tragically snuffed out prematurely. Based on this one example, we can conclude that it is certainly possible that VAERS is deliberately removing any records from ever being seen by the public that are clearly very incriminating. was it just coincidence, that the record which the public would never have known about was the record of a 2 year old, who would have been ineligible to receive the Covid-19 inoculations (outside of a clinical trial) and whom furthermore died within six hours of the inoculation in a horrible manner was this a form of silent censorship and gas lighting.
